GRANFONDO: 166.8km: LIVIGNO (Aquagranda), Forcola di Livigno (GPM), junction for Passo Bernina, Passo Bernina (GPM), Pontesina, Samedanm, La Punt, Zernez, junction for tunnel Mont la Schera, Pass dal Fuorn (GPM), Tschier, Santa Maria Val Mustair, Umbrailpass (GPM), Stelvio Military Memorial, junction for Livigno, Isolaccia, Arnoga, Passo del Foscagno (GPM), Passo di Eira, LIVIGNO (Mottolino).

SHORT: 106.5km: LIVIGNO (Aquagranda), Forcola di Livigno (GPM), turnoff to Passo Bernina, Passo Bernina (GPM), Pontesina, Samedanm, La Punt, Zernez, turnoff to tunnel Mont la Schera, tunnel exit, Livigno centre, Passo di Eira (GPM), LIVIGNO (Mottolino).

## PARTICIPATION

The Granfondo LIVIGNO Alé is open to all FCI members aged 17 and over in the calendar year. There are no limits to participation in the M8 category as long as they are in possession of a membership card or a daily card medical certificate.

## MEMBERS OF SPORTS PROMOTION ORGANISATIONS

Participation is also open to all members of Sports Promotion Bodies in possession of sporting medical fitness for competitive cycling that have signed an agreement with the F.C.I. for the year 2024, with the exception of ASI members who must also present the Bike Card 2025 alongside their membership card.

## FOREIGN MEMBERS

The event is also open to all foreign amateur cyclists in possession of a UCI licence valid for the year 2025, issued by their national cycling federation, which must be presented together with a certificate of competitive sporting ability for cycling (no other disciplines!) in English, as per the model downloadable here [Health Certificate - ENG - Annex E](#) or [Certificat médical - FRA - Annex E](#)

## NON-MEMBERS (Italians and foreigners)

The event is also open to all non-members from Italy and abroad, for whom a FCI day card will be activated at a cost of €10.00 for 'third-party liability' insurance cover during the event. For the day card to be issued, a certificate of Competitive fitness (cycling no other disciplines) must be presented pursuant to DM 18/2/82.

*The event is by invitation only and the organising committee may at any time and at its sole discretion decide whether or not to accept an entry or exclude an entrant from the event in the event that it might damage its image.*

## MEDICAL CERTIFICATE

Participation is subject to regular possession of the following requirement:

- for athletes registered with the FCI or a sports promotion organisation: certificate of fitness for competitive cycling (certificates for other types of sport such as triathlon, duathlon, athletics, etc. are not valid);
- for subjects of Italian residence but not registered with the FCI or sports promotion bodies: certificate of fitness for sporting activity;

-for foreign residents: certificate of fitness to participate in competitive cycling competitions also issued by a doctor in their country of residence as per the format downloadable here: [Health Certificate - ENG - Annex E](#) or [Certificat médical - FRA - Annex E](#)

*By submitting the online or paper entry form, the foreign competitor declares that he or she has accident insurance and third-party liability insurance.*

Possession of a sports card may only be regarded as an alternative to verification of possession of a regular and appropriate certificate in the case of a sports card bearing the DataHealth logo together with the expiry date of the certificate of fitness for competitive cycling.

Participation for professional (contracted elite), elite and under23 athletes

Professionals, elites (men and women) and under 23s are only admitted for promotional purposes, subject to authorisation from their sporting club to be shown to the Jury, and will not be allowed to take part in any way in the classification. According to the Implementing Rules approved by Presidential Resolution no. 59 of 31/10/2023 and ratified by the Federal Council on 11/11/2023, athletes who, in 2022 or 2023, are registered and registered for a UCI team, i.e. WorldTeam (WTT), Women's WorldTeam (WWT), ProTeam (PRT), Continental Team (CTM) and Women's Continental Team (CTW) cannot participate in the event. Athletes in possession of an amateur membership who, in the years 2023 and 2024, have been registered in the Elite, Under 23, Women Elite, Women Under 23 categories but do not fall under the above condition, may participate but are excluded from the category classifications, they may only be included in the overall classification with the indication "cat. ASS"

From 7 January 2025 to 30 April 2025: € 60.00

From 1 May 2025 to 23 June 2025: € 70.00

On Friday 27 June alone directly in Livigno: € 100.00

THE PARTICIPATION FEE IS NON-REDUCIBLE AND NON-REFUNDABLE, IT CAN BE FROZEN FOR THE FOLLOWING YEAR WITHIN THE TIME LIMITS SET OUT IN THE REGULATIONS.

## THE PARTICIPATION FEE INCLUDES:

- customised pectoral
- Alé cycling jersey
- various gadgets
- mechanical assistance (spare parts not included)
- running health care
- refuelling along the route
- broom service at the end of the race
- water refreshment on arrival
- *Food Quality Party* by the Pizzoccheri Academy at the finish line

## RACE PACKET COLLECTION

REFUND OF THE PARTICIPATION FEE: In the event that the member does not participate in the event, the fee paid will not be refunded. In the event of impossibility, to be notified STRICTLY by email by midnight on 09/06/2025, the entire fee may be kept valid for the 2026 registration.

The registration held valid for the following year is nominal and non-transferable to a third party and is valid only for the year following the waiver.

SUBSTITUTIONS BETWEEN ENROLLED ATHLETES: Substitutions between athletes are only permitted until 09/06/2025.

To make a substitution you must request the appropriate Form in the Secretariat by writing to [granfondo@livigno.eu](mailto:granfondo@livigno.eu)

RIGHTS AND DUTIES: *The competitor during the course of the event must always respect the control points provided in the route under penalty of exclusion from the final classification. The GF Livigno is a Competitive/Competitive event, therefore the rules of the road code must be strictly respected and observed. Riders who are overtaken by the "FINE RACE CYCLIST" car will continue the event as COMMON USERS OF THE ROAD while still keeping the dorsal on the back respecting the highway code. It is obligatory to wear the handlebar number clearly visible and not rolled up on the frame and the back number provided by the organisation. These numbers may not be changed in format. The use of a homologated, fastened hard helmet for the duration of the race. In order to protect the environment, it is absolutely forbidden for participants to throw rubbish of any kind along the roads; it is compulsory to place it exclusively in the special containers located near the refreshment posts and/or at the finish line. Anyone caught by the organisers and/or race officials not complying with this rule will be FINISHED UNTIL SQUALIFICATION.*

CONTROL POINTS: Start, along the route, Finish.

TIMER: Evodata Official Timer . Each participant must be equipped with a valid personal chip or a daily rental chip, which can be purchased/rented directly at the secretariat after collecting the race packet. AWARDED:

Prizes will be awarded:

- the first three (3) absolute short/ long distance finishers
- the first three (3) women classified overall Short/Grand Fondo
- for both courses, the first classified in the men's categories Elite/sport 19/29, Master 1 30/34, Master 2 35/39, Master 3 40/44, Master 4 45/49, Master 5 50/54, Master 6 55/59, Master 7 60/64 and Master 8 65 and over
- for both courses the first woman classified in the categories Sport Elite Women 19/29, Master Women 1 30/39, Master Women 2 40/49, Master Women 3 50 and over.

Special 'Segmento Pogacar' prize will be awarded to the athlete who comes closest to the time set by Tadej during the Giro on the stretch of road between the Eira Pass and the finish.

Any other prizes will be announced at the start.

Unclaimed prizes will NOT be sent home.

TEAM CLASSIFICATION: There is no team classification.

RIGID HELMET: Mandatory.

MEDICAL ASSISTANCE: ambulances, accompanying medical cars and moto-medics, doctors and qualified paramedical personnel.

MECHANICAL ASSISTANCE: Cars and motorbikes in tow and assistance points along the route.

PRIVATE ASSISTANCE: Any private assistance following the race is prohibited, under penalty of disqualification from the race and the runner(s) assisted. However, flying refuelling is permitted at the points provided by the organisation (see refreshment stations).

RADIO ASSISTANCE: along the route and at the finish line.

REFERENCE POINTS: at

- km 70 in Zernez
- km 119 Umbrailpass.

CANCELLATION OF THE EVENT: If, for reasons of force majeure, the event does not take place, the entry fee will not be refunded.

MANDATORY EQUIPMENT OF THE CYCLER: Cyclists taking part in a cross-country race must carry at least the following equipment with them at the starting line: - a set of tools for disassembling the tyre/tubular, a spare inner tube (or tubular); - a pump (or canister) for inflating the wheels; - a water bottle. In addition, all participants must, throughout the duration of the race, wear a type-approved rigid helmet and keep both the rigid race number in the frame and the dorsal number on the jersey attached in a legible manner.

COMPLAINTS: Complaints must be received by the Jury within the statutory deadlines accompanied by the F.C.I. fee.

#### COMPETENT COURT

*Any disputes arising from the application and interpretation of these regulations shall be settled by the Court of Brescia.*

*False self-certification will be prosecuted under the law.*

#### CASES OF CANCELLATION OR SUSPENSION OF THE EVENT:

1. The cases in which the event cannot be held that lead to its cancellation are cases caused by force majeure, fortuitous events, or any other kind not attributable to the organiser, such as

- Atmospheric events such as, but not limited to, snow, hail, cloudbursts, ice formation on the road or other weather conditions that make performance impracticable;
- Catastrophic events such as, but not limited to, earthquakes, floods, major fires, natural or man-made disasters;
- Nefarious event to the detriment of one or more participants;
- Provision or order of the public authorities, or of cycling promotion bodies or sports federations;
- Any other cause or event, not attributable to the organiser, that makes it necessary to cancel the event.

2. A cause or event not attributable to the Organiser shall be considered to be any fact or event of natural or man-made origin that is not the fault of the Organiser or to the occurrence of which the Organiser has not wilfully or culpably contributed.

3. The cancellation of the event shall be communicated by the organiser by e-mail, the address of which has been made known at the time of registration, or even just via social channels, as soon as possible, in order to allow participants to be informed in good time and to avoid any inconvenience as much as possible

4. If this is possible and in the absence of risk conditions, the organiser will arrange for the event to be postponed to another date, notifying the participants in good time.

5. However, this is without prejudice to the right of the organiser, if the concrete conditions allow it, to allow the event to take place by changing the planned route, in order to avoid dangerous situations for the runners.

6. If the event cannot be held, for the reasons set out in the preceding paragraphs, no amount will be due in repayment to the participants.

#### NORMS:

*All participants in the Granfondo are obliged to strictly observe and comply with the rules of the Highway Code, exercising the utmost caution and diligence in view of the dangers underlying the use of bicycles. For everything not indicated in these regulations, the rules laid down in the F.C.I. regulations apply.*

Participants are obliged to comply with all anti-Covid health indications and restrictions in force at the time of the event or provided by the organising committee.

*The Organising Committee and the Organisation disclaim all liability for accidents or damage to persons, animals and property, including bicycles, of any kind or nature whatsoever, which may occur before, during and after the Granfondo cycling event (i.e. by way of example, but not limited to, resulting from unfavourable weather conditions, uneven or impervious road surfaces, insufficient lighting).*

*Also for this purpose, participants who do not already have their own accident policy are strongly advised to activate one.*

*By registering for the Granfondo, the registered participant expressly accepts all the provisions of these regulations and undertakes to indemnify and hold harmless the Organising Committee and, in general, the Organisation, from any liability and from any claim and/or request for compensation for damage to persons and/or property that may arise from accidents of any kind and nature that may occur before, during and after the Granfondo*

*By use/processing of personal data we mean any operation or set of operations concerning the collection, recording, organisation, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, dissemination, distribution of data, even if not registered in a database in accordance with Article 7 of Legislative Decree No. 196/2003.*

*Each member has the right to exercise access to his or her personal data, as well as to obtain information about his or her data; to request its deletion, blocking, updating, rectification, integration, and to object to the processing of his or her data, by contacting Asd Cycling Brixia Team, with head office in via Piave 46, Castrezzato (BS), as the data controller.*

*By submitting the registration form online or by email with the signing of the appropriate form, the participant also expresses his or her consent, so that any photos, videos, audio - and/or video recordings, of any kind and type, that portray/reproduce him or her, produced during the event, may be freely memorised, reproduced, published and marketed by the Organising Committee, the Organisation and the sponsors, without any right to any related compensation and/or indemnity.
